Privacy Statement

Below you will find information concerning visits to and the use of CADtoWIN websites. For any and all Consulting or Services that are commissioned in person or otherwise, we retain your contact information and other relevant information required to fulfil our duties as commissioned by Privacy Policy / CADtoWIN and you.
